**Rachel Capoccia** focuses on intellectual property litigation with an emphasis on patent, copyright, and other technologyrelated litigation. A seasoned litigator with experience in all phases of patent litigation, Ms. Capoccia has represented clients in patent infringement matters involving diverse areas of technology, including digital cameras, software, biotechnology, telecommunications, video and audio conferencing systems, as well as medical devices. In addition to maintaining a robust practice, Rachel is an adjunct professor of copyright law at the University of Southern California Law School. Her legal experience is complemented by 10 years working at IBM as a software engineer before law school, during which she led a team of engineers who developed computer graphics software and computer aided design systems.

**Dominique Shelton** focuses on complex commercial litigation with an emphasis on intellectual property and privacy, as well as unfair competition and antitrust matters. She also provides strategic compliance counseling in digital marketing and data privacy on cutting-edge issues, such as mobile privacy, Big Data, Do Not Track, and behavioral advertising. In 2012, she was named Intellectual Property Lawyer of the Year by the Century City Bar Association. Dominique has litigated matters across various areas including the Fair Credit Reporting Act, Telephone Consumer Protection Act, Federal Trade Commission Act, Electronic Communications Privacy Act, Computer Fraud & Abuse Act, California False Advertising Law (Business & Professions Code §17500), California Unfair Competition Law and California Penal Code § 502. She has also negotiated with the CA AG and the FTC. Her clients come from a broad spectrum of industries such as media and entertainment, technology, broadcasting, digital sales and marketing, advertising, wireless/mobile, Internet, lead generation, manufacturing and electrical, software, telecommunications, legal services, automotive parts and services, dietary supplement, food and health/beauty.
